#### **Google License Changes -- Background**

- Virginia Tech's use of '*no-cost*' Google storage began in 2008.
- In 2021, Google announced plans to place costs and caps on storage. For VT, these new costs will be effective July 1, 2024.
- In response to these rising costs, Virginia Tech announced changes affecting the Google Workspace in **April 2023**. A second message regarding changes affecting Microsoft apps was shared in **August 2023**.



#### **Google License Changes -- Goals**

The goals of these changes are to:

- Responsibly administer the university's spending on collaboration platforms.
- Strengthen the university's cybersecurity posture by improving email protections and reducing data risk through the removal of abandoned data.
- Implement new processes that promote best practices for file and storage management, collaboration, and onboarding/offboarding of students and employees.
- Enable colleges, departments, and units to allocate resources to best meet the needs of their employees and collaborative culture.



# Google and Microsoft Apps for University Employees

Most of the services you're familiar with on both the Google and the Microsoft side will continue to be available. The only apps that are now unavailable are Google Photos, Gmail, and Google Calendar. Here's a partial summary of what's available:

#### **Email & calendar migrations are nearly complete**



of employees have been migrated

- Most VT employees have now transitioned to Exchange Online for email and calendar services.
- If your account has not been migrated, visit MyCAT (<u>mycat.ccs.vt.edu</u>) to confirm your migration date and status.
- We are here to help provide support as people settle into using the new tools.

# A few post-migration tips

- Review your inbox and consider <u>setting up new folders and rules in Outlook</u> to help you organize your messages quickly.
- Consider using <u>the archive feature</u> to regularly move older items from your primary inbox to a separate archive mailbox.
- Review your calendar for recurring meetings and ask meeting organizers to re-send invites if needed.
- If you find you are missing important content, your local IT professional can assist you in locating data. Submit a <u>4Help ticket</u> if additional assistance is needed.

### **Departmental Google Shared Drives**

- Employees & local IT professionals have made great strides in identifying and claiming thousands of Shared Drives.
- On February 15, all unclaimed Shared Drives were assigned zero GB of storage (this puts them in a read-only state).
- If you are a manager or a member of one or more shared drives, you can view your department's plan for your drive in MyCAT (mycat.ccs.vt.edu).



## **Google Shared Drive plans and storage cleanup**

By May 1, department plans for Shared Drives will be implemented, with four options available for each Shared Drive.

- **Keep:** The Shared Drive will remain in Google and will have an assigned storage limit.
- Migrate: Drives will be migrated out of Google to another storage location, such as SharePoint Online, and removed from Google once the migration is verified to be complete.
- **Remove:** Drives will be deleted from Google starting on May 1.
- Shared Drives that remain **unclaimed** by any department will also be deleted on this date.

#### Department Google Storage Plans

- On March 15, department storage plans go into effect for employee My Drives and departmental Shared Drives.
- Employees will receive between 5 GB of storage (the baseline) and a higher amount determined by their department.
- Departments receive a pool of additional storage (based on department size). This pooled storage can be used to increase employee My Drive or departmental Shared Drive storage assignments.
- Departments can select Google storage add-ons to augment their plans at no cost during this initial storage allocation phase. The storage add-on costs will go into effect starting July 2024.

### Departmental Google Storage Plans, cont'd.

- Departments are encouraged to discuss their storage allocation plans with employees. Look for emails or other messages from your local IT professionals.
- On or after March 15, visit <u>drive.google.com/settings/storage</u> to confirm your storage allotment in Google.
- Google will notify you in the Google Drive app when you have used 80% or more of your assigned storage.
- If you need additional storage, work with your local IT professional to determine best solutions to meet your needs.





#### **Know these key dates**

**March 15** - Departments/Colleges/Units implement Google storage allocation plans for individual employee My Drives and departmental Shared Drives.

**May 1 -** Departments confirm FY 2025 storage purchase estimates; deletion of unclaimed employee-managed Shared Drives begins.

July 1 - Google services operate under new cost-based licensing model.
